About life insurance coverage - please read this section before completing the form

The Government of Ontario offers two types of group life insurance coverage to eligible retired members -Basic life insurance (BLI) and Supplementary life insurance (SLI).

If you have either BLI or SLI, on your death a payment will be made to the person(s) you have named as beneficiary.

- BLI coverage provided by the PSPP is \$2,000. Amounts may differ for members of GO Transit, LCBO or Justices of the Peace.
- SLI coverage ends at age 65 unless you converted your SLI to an individual policy with Canada Life within 31 days.

You can name whomever you want as your beneficiary and you can change your beneficiaries at any time. As well, if you have both BLI <u>and</u> SLI, you can name different beneficiaries for each type of coverage.

IMPORTANT: Remember that designation of beneficiaries for pension death benefits is not the same as designation of beneficiaries for group life insurance. Group life insurance refers to BLI and SLI payable by Canada Life to the person(s) you named as life insurance beneficiary(ies) on this form. If you have group life insurance, any coverage is shown on the **Insured benefits** page in **e-services**.

To name or change beneficiaries, complete the section of this form that applies to you and return it to OPB. **Please note that each time you submit a new form, your past designations are cancelled.**

This means that if you are changing a beneficiary you must list <u>all</u> the beneficiaries on the form you want (attach an additional page if needed). If not, they will no longer be eligible for the benefit.

- If you have designated one BLI beneficiary and you want to add a second, you must complete a new designation form naming <u>both</u> beneficiaries.
- If you name the second person only, the other beneficiary will no longer be eligible for the benefit. If you had designated beneficiaries for your SLI, you must also rename them on the new form.

If you are receiving a survivor pension from the PSPP, do not use this form as you are not eligible for this group life insurance coverage.
